1. Welcome / Introductions:

2. Meeting Minutes

Action: Approval of Meeting Minutes for June 26, 2019 (Stanislaus County) by Stephanie Hiestand (City of Tracy) first motion and seconded by John Vance (City of Patterson).

3. NPDES Phase II Permit Updates

Update: Per Stephanie Hiestand, City of Tracy and CASQA Committee Member, year five (5) of the MS4 Phase II permit cycle ended June 30, 2019. The State has been working on the updated permit for some time and it is anticipated that the new permit will be released in the Fall 2019. Changes are coming including the schools being brought into the Phase II coverage. This will be a big thing for the schools/non-trationals, and they will now have to have their own stormwater programs in place to address stormwater regulations. Unsure at this time as to how much input/facetime this permit would allow for.

4. Stormwater Construction Permit Updates

Update: In addition to releasing the MS4 Phase II permit, the State is also going to be releasing the new General Construction permit. Per Bret Smith, Compliance First, the final document is scheduled for public review next month (August 2019). The main changes under the new permit for construction sites will require more physical presence and participation from all QSDs. They will have to be involved more and will have more accountability with the sites now. The REAPs (Rain Event Action Plans) will go away and TMDL requirements would be part of this new permit.

Stephanie Hiestand, City of Tracy, advised that additionally, no projects will be allowed to file the Notice of Termination until they have uploaded the post-construction Agreements & O&M manuals to SMARTS. This also applies to the City Projects. The State has accepted a standard statement developed by Stephanie and is willing to accept it written certification from Agencies that they give to sites at "Final" stating that they have complied/ filed the Agreements & O&M manuals with the City for all storm water post construction/LID installed as part of the project. Most of the projects are installing underground storage, retention/detention basin, and bio-swales.

This also applies to all City projects; however, Stephanie has developed another letter/certification that will be sent to the State for City owned projects stating that it is a City project and that the City will own and maintain the sites. Cities are funding for on-going O&M by setting up CFDs for all the residential areas. Annual reminder letter should be sent to the owners advising them of the due date for the annual certifications. Due dates for these should be 15 – 30 days after the agreement is executed. For example, if the agreement was signed 7/1/18, the certification would be due to the City by 7/16 -7/31 of every year.

The City should perform inspections to make sure that the SCMs are not failing and ensure proper maintenance and review all maintenance records.

5. SJVSWQP Partnership for Public Outreach/Education

2020 Regional Training in May:

- a. *Subcommittee Election was discussed. Everyone was on board with having the same members on the subcommittee as last year which included: 1) Dagmara Saini, City of Manteca 2) Sonia Delgado, City of Patterson, 3) Caleb Smith, City of Tracy, 4) Rosemary Martinez, City of Lathrop (was City of Ceres), 5) Kathy Grant (City of Lodi). The subcommittee will meet to select the subcommittee leaders for this year. Anyone else willing to take participate in the subcommittee is welcome and current members are willing to step down and allow others the opportunity.*
- b. *Training Topics & Outline. The subcommittee members would meet to discuss the topics and training outline to share with the group on upcoming monthly meeting(s). Topics would be selected upon approval of the new MS4 Phase II and Construction permits so they can provide training on the new requirements. This training might be a large one.*
- c. *Training Cost would be determined based on the 2019 total costs report provided by Lisa Smith, Compliance First. However, the subcommittee needs to make sure that the new fee covers all time/costs for Compliance First. Raffle prizes and giveaways would be requested from Vendors by the subcommittee this year.*

Other 2019/20 Upcoming Trainings

- a. *Stormwater Awareness Week by WGR Southwest is scheduled for September 2019. Next SJVSWQP in September will include some of the WGR Awareness week videos/webinars to share with the group, like last year in Escalon.*

Sonia Delgado, City of Patterson brought up the Radio Ad and provided the following details. Everyone agreed for Sonia to take the lead on this one and to move forward with putting together a script and proposal for the group during upcoming partnership meetings. The new radio ad would cover 2020/21. Stephanie, City of Tracy, shared information with the group regarding their TV commercial through Comcast. The cost is \$9,000 and she will be providing further information on the process/coverage areas. She mentioned that the group can use their TV commercial but would have to work with Comcast to update agency information as theirs mentions City of Tracy. d. *15 Cities/Agencies Participated in 2018 Radio Ad, none in 2019*

e. *60 second Script:*

*“As we move into the summer and drier weather, the last thing we think of is Stormwater runoff. In the dry summer months, runoff can occur from overwatering lawns and washing our cars. This non-stormwater runoff collects in our storm drains carrying many different types of pollution, including trash, debris, dirt, pet waste, lawn clippings, pesticides and fertilizers or chemicals which makes its way into our local creeks, lakes, rivers and eventually the ocean. We use these water sources for swimming, fishing and drinking water. Keeping our storm drains clean to protect our water supplies is our responsibility. The cities of Patterson, Turlock, Livingston, Escalon, Newman, Tracy, Manteca, Riverbank, Lodi, Hughson, Ripon, Escalon, Ceres, the Port of Stockton, County of San Joaquin, and County of Stanislaus reminding you to prevent runoff and keep our storm drains clean....So always remember..... **Only Rain Down the Drains!**”*

6. SJVSWQP Membership Dues & Website

a. *Stephanie Hiestand, City of Tracy, advised that City of Tracy might be able to establish the accounting for the group, however, she needs confirmation from her Finance Director. She should have a status for the group at the upcoming meeting.*

7. Upcoming SJVSWQP Collaboration Efforts

a. *Pyrethroids 13267 Letters Update. Paul Bedore from Robertson-Bryan, Inc. provided the group with an update and detailed background on the requirements of the upcoming Pyrethroid Pesticide Basin Plan Amendment for the Central Valley. A copy of the information is attached. In summary, Pyrethroid Pesticides is a hot topic right now. We had RBI consulting firm provide the group information, see attached, on this requirement as well as update. From what we were told yesterday, the State is getting ready to issue a 13267 or 13383 order very soon (next few weeks or as soon as next week). This can be a huge financial impact to the Cities/Agencies as it will require the City to put together a Management Plan in lieu of Baseline Monitoring. If a plan is not done, then the City would be required to perform baseline monitoring which includes toxicity, pyrethroid testing, and water/sediments 4x per year. The monitoring plan would have to be submitted to the state by June 2020 and the monitoring must be completed by October 2021!! There is the possibility that the State just roll in this requirement into the Delta Regional Monitoring Program (DRMP), which the City participates in and pays every year (\$10K). The fee for a regional state monitoring program is being estimated at another \$10K minimum for each agency! Please keep an eye out for any information that comes through regarding the 13267/13383 orders/letters/communications. These would be addressed to the Cities/Agency's LRPs.*

b. *The group discussed working together, similar to the Stormwater Post-Construction/LID standards manual, to put out an RFP (Request for Proposals) and develop a Regional Pyrethroid Pesticide Management Plan to address the Pyrethroids 13267 or 13383 orders that are coming before us very soon. This can be discussed further in the upcoming meetings and/or once all agencies receive the pending state order(s).*

c. *CV Salts Update. No updates at this meeting.*
